January 13, 2020 Special Meeting

A special meeting of the Mayor and Council of the Borough of Bay Head was held on January 13, 2020 at 6:00 pm in the Municipal Building, 83Bridge Avenue, Bay Head, New Jersey.

Mayor Curtis called the meeting to order and welcomed everyone. She asked everyone to stand and join in the Pledge of Allegiance to the Flag.

Mayor Curtisread the following statement:

Ladies and gentlemen, pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. This meeting was posted in the lobby of the Municipal Building at 83 Bridge Avenue on January 7, 2020 and published in the Ocean Star on January 10, 2020 and the Asbury Park Press on January 7, 2020.

The roll was called for attendance. Present were Mayor Curtis and Councilmembers Cornell, Barnes, Shaning, MacPherson, (Lyons arrived at 6:05 pm), Borough Administrator, Chris Parlow and Borough Attorney, Jean Cipriani.

Mayor call for Resolutions:

Councilmember Cornell offered Resolution 2020-44 authorizing the transfer of appropriations in the Calendar Year 2019 Budget and moved its approval. The motion was seconded by Councilmember Barnes and passed on roll call vote. YEAS: Cornell, Barnes, Shaning, MacPherson. A copy of the resolution is attached to these minutes.

Mayor Curtis opened the meeting to the public.

Theresa Jankowski, 163 Park Avenue: What are the stakes on Park Avenue?

Mr. Parlow: It could be marked by the water company contractor. They had to some back and fix the sink holes.

Ms. Jankowski: Why stake out on the home owners property? They stakes are also up Willow Drive. I asked public works but they didn't know.

Mr. Parlow: That is the only work I am aware of. They just had to come back and repair their patch work.

Mayor Curtis: Dennis could you introduce Holly to our water company contact to check on this.

There being no further comments Mayor Curtis closed the public portion.

- 2. The following subject involve: Contractual matters relating to Cellular Antenna Providers.
- 3. It is anticipated at this time the above stated subject matters will be made public within 90 days.
- 4. No action will be taken after the Executive Session.
- 5. This Resolution shall become effective immediately.
